**Draft Resolution the United Nations President General Assembly, concerning long-windwd/longest
Unsettlement case of Republic of South Moluccas/RMS during the era of United Nations policy**

Resolution	Round Table Conference, 29 December 1950, based on the Resolution UNSC 28 January 1940 (S/1234) and RES/491 (V), 289 th Plenary meeting, 28 September 1950

Represent	Entire South Moluccas People
Topic	Agreement of the Decolonization territory in Hindus Neso (Indonesia) and agreement became a membership/491 (V).

Heading the case of Republic of South Moluccas/RMS, proclaimed of April 25, 1950, de Facto de jure according to its freedom before all accupotion and according to all decolonization stipulation but still fluctuated, up to date.

Researching the long-winded case of the RMS and constituted the longest case unsettlement in the era of United Nations policy for its annexation into the barbaric grip of Unitary State of Indonesia/NKRI up to now (75 Years old), since July 1950.

Considering that the NKRI Declared at August 15, 1950 is not the Republic of Indonesia/RI, August 17, 1945 and also is not the United Stated of Indonesia/RIS, December 27, 1949.

Emphasizing that the Republic of South Moluccas/RMS, proclaimed at April 25, 1950) is the same right with Republic of Indonesia/RI, August 17, 1945 and Indonesian Federation/RIS given to those by Round Table Conference/RTC December 27, 1949.

Stating the facts as follows:

1. **RI and RIS melted** themselves into the **NKRI (August 15, 1950) by breaking all over laws of Self-Determination** for the decolonization namely, RTC (December 29, 1949), RIS constitution (January 31, 1950), Linggarjati agreement (March 25, 1947), Renville agreement (January 17, 1948), Roem van Royen agreement (May 7, 1949), Security Council of United Nations' Resolution, January 28, 1949, **through military aggression** (really illegally action), (How come it is go to be? and who are they?).
2. **RMS proclaimed itself at April 25, 1950 as an "Existing State"** via plebiscite and Decision of South Moluccas Council according to what recommended by RTC and all Self-determination laws at that moments.
3. RI was dismissed by Soekarno President at 15 August 1950 at Jogjakarta.
4. **NKRI practice military aggression towards RMS since July 1950 thus far.**
5. Indonesia in this case is NKRI deceives the United Nations through the Resolution of 491 (V) as **a defect resolution, where for that moment no more RI and RIS but merely NKRI.**

Request UNGA to place the issue of the General Assembly Resolution UNSC S/1234, (Round Table Conference, 29 December 1950) and RES/491 (V), 289TH Plenary meeting, 28 September 1950 into the agenda of the trusteeship Council to discuss in the General Assembly Session September 2025 and **Urge** UN President General Assembly to **restore** the original meaning of General Assembly Resolution UNSC S/1234, (Round Table Conference, 29 December 1950) for the benefit of all component territory of Indonesia; **Restore** the State Sovereignty of RMS to the rightfully people (South Moluccas People); and **dismiss** the illegally NKRI.

The Key to the solution is that UNCI and the Dutch must be held responsible for their mistake int the South Moluccas fatalities up to date.
